**ARTICLE I**

**NAME AND OBJECTIVES**

Section 1. **NAME:** This Association shall be known as the Peace Officers Research Association of California (PORAC).

Section 2. **OBJECTIVES:** The objectives of this Association are to unite all persons within its jurisdiction for their economic, professional, and social advancement. It shall be the aim of the Association to assist all public safety officers in seeking adequate compensation for the performance of their professional duties and to improve conditions of employment, accomplished through collective legal activities, collective efforts in all areas of labor presentation, collective attempts to insure themselves and their families against health, disability, accident, and any other problems that may occur; to collect, study, standardize, summarize, and distribute factual data in order to promote the professional qualifications and standing of public safety officers.

Section 3. **PRINCIPLES:** The Association is founded on the principle that public safety officers united in mutual interest and acting in a spirit of cooperation, may, through the free exercise of their constitutional freedoms of association and self-organization, best promote their own welfare.

Section 4. **HEADQUARTERS:** The Headquarters and general offices of this Association shall be located in Sacramento, California, and shall remain situated in that city until removed by referendum vote of the membership.

1 **ARTICLE II**

2 **MEMBERSHIP**

3 Section 1. The membership of Peace Officers Research Association of California (PORAC) is  
4 comprised of member associations and individuals as provided in these Bylaws.

5 A. PORAC respects the integrity of law enforcement associations and the right of  
6 such entities to maintain and protect their established bargaining relationships with  
7 the public agency employing their members. Any organization or individual who  
8 seeks to decertify a lawfully recognized law enforcement association serving as the  
9 bargaining representative of peace officers shall not be permitted affiliation with  
10 PORAC.

11 B. PORAC respects the established affiliation of law enforcement associations with  
12 other labor or fraternal organizations. Any law enforcement association or  
13 individual who breaks its affiliation with another labor or fraternal organization may  
14 only apply for membership with PORAC after twenty-four (24) months, except as  
15 otherwise provided by the PORAC Board of Directors.

16 C. All applications for membership in PORAC shall include the proposed effective  
17 date as well as a current and complete membership roster which contains the  
18 following information regarding each member:

- 19 1. First and Last Name
- 20 2. Date of Birth
- 21 3. Home Address
- 22 4. Member Type (Sworn, Non-Sworn, or Retired)

1 **ARTICLE II (Cont'd.)**

2 **MEMBERSHIP**

3 Section 2. There shall be seven (7) classes of membership in PORAC including Active, Retired,  
4 Honorary, Associate, Reserve, Limited and Out of State Members.

6 Section 3. **ACTIVE MEMBERSHIP** shall consist of:

7 A. Employee organizations recognized as an exclusive bargaining representative of a  
8 public agency whose membership consists of Peace Officers as defined in Section  
9 830 et seq. and Public Officers as defined in Section 831 et seq. of the California  
10 Penal Code.

11 1. Employee organizations whose sworn members constitute a majority of the  
12 bargaining unit may apply for active membership in PORAC on behalf of both the  
13 sworn and non-sworn members.

14 2. Employee organizations whose sworn members do not constitute a majority of  
15 the bargaining unit may only apply for active membership in PORAC on behalf of  
16 all their sworn members. The non-sworn members of such an employee  
17 organization may only be granted Limited Membership if approved by the PORAC  
18 Board of Directors.

20 B. Applications from management, Public Officers, and reserve associations will not be  
21 considered for active membership unless submitted with a letter from the  
22 corresponding PORAC rank-and-file association stating they are not opposed to or  
23 support the application. No recommendation is needed for the application if the rank-  
24 and-file organization is not a PORAC active member. (S.R.)

2 **MEMBERSHIP**

3 C. Retired peace officers who retain active membership and pay such dues through  
4 their local association.

5 D. Active membership includes at-large associations.

7 Section 4. **RETIRED MEMBERSHIP:** There shall be three (3) classes of Retired Membership.

8 A. **RETIRED ASSOCIATE MEMBERSHIP:** Any sworn retiree from a California agency.  
9 Retired sworn officers from a non-PORAC affiliate must show appropriate supporting  
10 documentation to become a Retired Associate Member (RAM).

12 B. **RETIRED LIMITED MEMBERSHIP:** Any non-sworn public safety related person  
13 who, upon retirement, desires to maintain PORAC affiliation may be a Retired Limited  
14 Member (RLM). (S.R.)

15 C. **RETIRED OUT OF STATE MEMBERSHIP:** Any sworn officer who retired from an  
16 agency outside of the State of California. Retired Out of State Membership (ROSM) is  
17 limited to group membership through a group membership program approved by the  
18 Board of Directors.

20 Section 6. **JOE ACETO HONORARY LIFE MEMBERSHIP:** The Joe Aceto Honorary Life  
21 Membership may be conferred upon any person rendering extraordinary service to the  
22 goals and objectives of PORAC. (S.R.)

24 Section 7. **RESERVE MEMBERSHIP:** Reserve membership shall consist of associations made up  
25 of reserve peace officers. (S.R.)

1 **ARTICLE II (Cont'd.)**

2 **MEMBERSHIP**

3 Section 8. **STANDARD ASSOCIATE MEMBERSHIP:** Standard Associate Membership (SAM) shall  
4 be those individuals approved as provided by these Bylaws. (S.R.)

5 Section 9. **LIMITED MEMBERSHIP** shall only be available to the following organizations:

6 A. Public safety organizations not eligible for other membership.

7 B. The Executive Committee or Board of Directors may give approval to grant limited  
8 membership to any newly applying association otherwise eligible for full PORAC  
9 membership for a period up to but not to exceed twelve (12) months.

11 C. Applications from management, Public Officers, and reserve associations, not  
12 accepted for active membership shall be allowed to apply for limited membership.

14 Section 10. **OUT OF STATE MEMBERSHIP** shall only be available to out of state public safety  
15 organizations.

16 Section 11. Membership shall be approved or denied by the Board of Directors or the Executive  
17 Committee. (S.R.)

19 Section 12. Limited members have no rights in PORAC except (a) to participate in the Legal Defense  
20 Fund (LDF), Retiree Medical Trust (RMT), and Insurance and Benefits Trust (I&B)  
21 programs for which they qualify, and (b) to attend PORAC sponsored trainings and events  
22 on par with other affiliated associations.

**ARTICLE II (Cont'd.)**

**MEMBERSHIP**

Section 13. Only employee organizations recognized as the exclusive bargaining representative by the public agency employing law enforcement offices may seek or maintain Active, Limited or Reserve Association Membership in PORAC, except as otherwise provided by the PORAC Board of Directors.

1 **ARTICLE III**

2 **DUES**

3 Section 1. Active membership organizations shall pay dues at the rate of nine dollars (\$9.00) per  
4 capita per month. Beginning January 1, 2027, Active membership dues shall increase fifty  
5 cents (\$0.50) in odd numbered years, in perpetuity. The Board of Directors shall  
6 reevaluate the dues increase structure a minimum of every five (5) years. The Pension  
7 Protection funds collected through December 31, 2024, shall be specifically allocated to  
8 protect and defend member's pension benefits adversely impacted by any type of  
9 California pension reform. Non-active dues paying members, as listed below, shall pay  
10 dues in the manner prescribed in the Bylaws and Standing Rules.

12 Section 2. Reserve peace officer associations shall pay dues at the rate of forty-eight dollars  
13 (\$48.00) per capita annually.

15 Section 3. Retired Associate Members (RAM), Retired Limited Members (RLM), and Retired Out of  
16 State Members shall pay dues at the rate of thirty dollars (\$30.00) per capita annually.  
17 Effective January 1, 2027, the annual per capita dues shall increase to thirty-two dollars  
18 and fifty cents (\$32.50). Effective January 1, 2028, the annual per capita dues shall  
19 increase to thirty-five dollars (\$35.00). Effective January 1, 2029, the annual per capita  
20 dues shall increase to thirty-seven dollars and fifty cents (\$37.50). Effective January 1,  
21 2030, the annual per capita dues shall increase to forty dollars (\$40.00). Effective January  
22 1, 2031, the annual per capita dues shall increase to forty-two dollars and fifty cents  
23 (\$42.50). Effective January 1, 2032, the annual per capita dues shall be forty percent  
24 (40%) of Active member dues, rounded up to the nearest quarter.

1 **ARTICLE III (Cont'd.)**

2 **DUES**

3 A. Retired Associate Members (RAM) who opt to withdraw from RAM, and subsequently  
4 seek to regain RAM membership, shall pay, in addition to their new dues, the amount  
5 of any delinquent dues owed at the time of their withdraw.

6 B. The Retired Associate Members (RAM) dues shall be waived if the member's  
7 association from which they retire keeps their status active. However, such RAM  
8 dues paying members shall not count for purposes of determining voting strength  
9 under Article X, Section 2 (C) of these Bylaws

11 C. Retired Out of State Membership (ROSM) dues shall be collected and remitted to  
12 PORAC under the terms of the group membership program approved by the Board of  
13 Directors.

15 Section 4. Standard Associate Members (SAM) shall pay dues equivalent to the rate of dues set for  
16 Retired Associate Members.

2 **DUES**

3 Section 6. Limited membership organizations shall pay monthly per capita dues of forty percent  
4 (40%) of Active member dues, rounded up to the nearest quarter dollar. Limited member  
5 associations who opt to withdraw from PORAC, and subsequently seek to regain limited  
6 membership status, shall, over the same number of months they were without PORAC  
7 limited membership, pay, in addition to their new dues, the amount of dues that would  
8 have otherwise been paid if they had maintained continuous limited membership.  
9 However, the above dues payback shall be waived if the former limited members attain  
10 active member status.

12 Section 7. Out of State Limited Membership organizations shall pay dues or fees as set by the  
13 Board of Directors or Executive Committee.

14 Section 8. As applied in these Bylaws, the term "per capita" shall mean all members of an affiliated  
15 Active, Reserve, Limited or Out of State Limited membership organization. Affiliated

1 **ARTARTICLE IV**

2 **REGIONS/CHAPTERS**

3 Section 1. The membership of PORAC is geographically divided into four (4) Regions, each of  
4 which is further divided into Chapters. (S.R.)

5  
6 Section 2. Each Chapter may be comprised of non-at-large associations, at-large associations,  
7 associate members, retired members, statewide association members and Federal  
8 Coalition members.

9 A. Non-at-large associations are active member organizations with fewer than five  
10 hundred (500) individual members.

11 B. At-large associations are active member organizations with five hundred (500) or  
12 more individual members.

13 C. Statewide associations are active member organizations whose membership  
14 transcends the boundaries of the various Regions and Chapters. Statewide  
15 associations' members are not members of a local Chapter but are members of the  
16 Statewide Chapter. They may attend any local Chapter meeting but may only  
17 exercise their rights within the Statewide Chapter. (S.R.)

18 D. Federal Coalition is comprised of active member organizations whose membership  
19 transcends state boundaries.

21 Section 3. The boundaries of the various Regions and Chapters within California shall be  
22 established. A map indicating the names, numerals, and boundaries of the Regions and  
23 Chapters approved by the Board of Directors shall be attached to these Bylaws.

1 **ARTICLE V**

2 **POWERS**

3 Section 1. The Conference of Members shall, when in session, possess the power to amend these  
4 Bylaws, elect officers, and other powers as provided herein.

5  
6 Section 2. Subject to the authority of the Conference of Members, the activities and affairs of  
7 PORAC shall be governed and all corporate powers exercised by or under the direction  
8 of the Board of Directors.

9  
10 Section 3. Subject to the authority of the Board of Directors, when the Board of Directors is not in  
11 session, the Executive Committee shall have all the powers and authority of the Board  
12 of Directors subject to the direction of the Board of Directors except when prescribed by  
13 law, Standing Rules, and/or these Bylaws.

15 Section 4. The Executive Committee shall have no power to adopt, amend, or suspend the  
16 Standing Rules.

17  
18 Section 5. Chapters shall establish Bylaws and elect officers to administer their affairs.  
19 A. The Bylaws and actions of the Chapters shall not be in conflict with the Bylaws or  
20 principles of PORAC. The Bylaws of the Chapters, and any amendments thereto, shall  
21 be submitted to and become effective upon approval of the PORAC Board of Directors.

2 **OFFICERS/BOARD OF DIRECTORS/EXECUTIVE COMMITTEE**

3 Section 1. The officers of PORAC shall be the President, Vice President, Treasurer, and Secretary.

5 Section 2. The Board of Directors shall be comprised of the President, Vice President, Treasurer,  
6 one (1) Director from each at-large association (who shall be a member of that at-large  
7 association), one (1) elected Director from each Chapter (elected by non-at-large

9 Members (RAM) Committee, and, for a one (1) year term, the immediate Past President.

6 D. The Board of Directors shall retain the power to remove Executive Committee  
7 members as provided in Article XII of these Bylaws.

2 **MEETINGS**

3 Section 1. The Conference of Members shall be convened annually, during the last quarter of the  
4 year, as determined by the Board of Directors. (S.R.)

5 A. Written notice of the time and place of the Conference shall be given not less than  
6 thirty (30) days prior to the Conference of Members.

7 B. A quorum shall consist of the members present.

9 Section 2. The Board of Directors shall meet at least twice annually, in addition to the meetings at

17 C. A meeting may continue notwithstanding the loss of a quorum except that no vote  
18 may occur in the absence of a quorum.

3 Section 1. The President shall preside at all meetings of the Board of Directors, Executive

6 may call meetings of the Board of Directors and the Executive Committee and shall be

18 Section 3. The Secretary shall be responsible for the preparation and certification of the minutes of  
19 meetings of the Executive Committee, Board of Directors, and the Conference of  
20 Members. He/She shall make a regular report to the members on meetings of the  
21 Executive Committee and the Board of Directors. He/She shall maintain custody of the  
22 Articles of Incorporation, Bylaws, and Standing Rules. He/She shall perform such other  
23 duties as may be delegated by the Board of Directors, Executive Committee, and these  
24 Bylaws.

2 **DUTIES**

3 Section 4. The Treasurer shall be the chief financial officer responsible for ensuring compliance  
4 with the fiscal policies of these Bylaws, the Board of Directors, and Executive  
5 Committee. (S.R.)

7 Section 5. A member of the Board of Directors shall perform the duties of a Director, including  
8 duties as a member of any committee upon which he/she may serve, in good faith, in a  
9 manner he/she believes to be in the best interests of PORAC, and with such care,  
10 including reasonable inquiry, as an ordinarily prudent person in a like position would use  
11 under similar circumstances.  
12

13 Section 6. Chapter Directors shall insure Chapter compliance with PORAC Bylaws, Standing Rules,  
14 policies, procedures and shall be a local representative of PORAC for all local matters  
15 except contractual obligations.

6 election shall be included in an immediate run-off election.

7 A. Nominations shall be made at the August meeting of the Board of Directors preceding

9 may be submitted in writing, provided the nomination is received by PORAC prior to

1 **ARTICLE XI**

2 **TRUSTS AND STANDING COMMITTEES**

3 Section 1. Each of the Trust Funds and Standing Committees provided for in this Article were  
4 created by the PORAC Board of Directors for the benefit of the affiliates of PORAC and  
5 their members. Those serving as representatives of any PORAC Trust Fund have a  
6 fiduciary obligation on behalf of their participants and beneficiaries. The PORAC Board of  
7 Directors delegated responsibility for and authority over each respective Trust to a Board  
8 of Trustees. Each of the PORAC Trust Funds and Standing Committees shall submit an  
9 annual report to the PORAC Conference of Members, including appropriate  
10 organizational and financial information.

11 Section 2. On July 1, 1974, the PORAC Board of Directors established a legal services benefit plan  
12 trust known as the PORAC Legal Defense Fund (LDF). The Legal Defense Fund Trust  
13 shall govern and direct the administration of the Legal Defense Fund.

15 A. The Trust shall consist of five (5) Trustees who are beneficiaries of the LDF, who shall  
16 choose a chairperson.

approved by the PORAC Legal Defense Fund Board of Trustees.

3 C. Federal officer organizations within California may participate in PORAC Legal  
4 Defense (LDF) programs without becoming members of PORAC, provided they meet

6 Fund Board of Trustees.

8 Section 3. On May 17, 1991, the PORAC Board of Directors establish an insurance and health

2 **TRUSTS AND STANDING COMMITTEES**

3 Section 21. The President may appoint a Fund A Hero Committee. When and if appointed, this  
4 Committee shall be responsible for reviewing and implementing the policies and  
5 procedures of the organization pertaining to an in-house fundraising platform for eligible  
6 current and retired law enforcement officers, in accordance with POREF Bylaws Article  
7 VII, Section 8. The POREF Board of Directors shall serve as the Fund A Hero  
8 Committee.

10 Section 22. Historical Committee: The Historical Committee is a standing committee responsible for  
11 maintaining an ongoing record of PORAC activities and historical records including  
12 Lifetime Membership, Past Presidents and meeting minutes. The Committee will consist  
13 of a designated Historian, who shall serve as the Chair of the Committee, and four (4)  
14 members, all of whom are appointed by the President, subject to the approval of the  
15 Board of Directors.

3 Section 23. The Communications and Technology Committee: The Communications and  
4 Technology Committee shall receive, review and make recommendations related to all

6 evaluate emerging technologies and the expansion of current technologies that would  
7 benefit PORAC and its Chapters, affiliated associations and their members, as well as  
8 the PORAC LDF, I&B, RMT and other affiliated entities. The Committee may utilize  
9 outside resources with prior approval of the PORAC Executive Committee. The  
10 Committee shall consist of five (5) members, one (1) from each Region and a

14 Section 24. Each of the Trust Funds and Standing Committees provided for in this Article were  
15 created for the benefit of the affiliates of PORAC and their members. Those serving as  
16 representatives of any PORAC Trust Fund or Standing Committees have a fiduciary  
17 obligation on behalf of their participants and beneficiaries. Each of the PORAC Trust  
18 Funds and Standing Committees shall submit an annual report to the PORAC  
19 Conference of Members, including appropriate organizational and financial information.

2 **INVESTIGATIVE POWERS**

3 Section 1. PORAC requires integrity from all individuals and entities involved with the Association.  
4 Any person may be disciplined for any act or offense constituting a violation of PORAC's  
5 Articles of Incorporation, Bylaws, Standing Rules, Rules of Order, or which may  
6 otherwise be detrimental to PORAC or a conflict of interest. An Ad Hoc Ethics  
7 Committee shall be responsible for investigating any issues of alleged impropriety  
8 involving officers, directors, trustees, representatives, vendors, professionals and any  
9 others providing services to or on behalf of PORAC or its members.

11 Section 2. Following such investigation, the Committee shall report any findings and may make  
12 recommendations to address those findings to the PORAC Executive Committee or the  
13 Board of Directors. The Executive Committee or Board of Directors may take any action  
14 deemed appropriate. The Ethics Committee shall consist of four (4) members of the  
15 Board of Directors appointed by the President. The Ethics Committee shall appoint one  
16 of its members to serve as Chair. Ethics Committee members shall recuse themselves  
17 from the Committee with regard to any referred matter presenting a personal conflict of  
18 interest. Any appointment to fill such a vacancy on the Ethics Committee shall be made  
19 by the President.

3 B. An Investigative Committee shall be formed consisting of one (1) member from each

6 allegations made against the accused individual(s). The Committee shall then  
7 conduct a thorough investigation into these allegations, reporting their findings,  
8 including recommendations and any dissenting minority report, to the Board of  
9 Directors in Executive Session.

11 C. If the Board of Directors, by a weighted majority vote, concludes that the findings of

15 served on the accused. Pending the hearing, the Board of Directors may take any  
16 appropriate temporary action to protect and defend PORAC from irreparable harm.

19 exculpatory evidence, to answer the charges preferred against him or her. The

3 E. If the charges or any portion thereof, are sustained, the Board of Directors shall  
4 render judgment and may impose any appropriate disciplinary action, which shall be  
5 implemented immediately, excluding removal from office of elected officers which  
6 must proceed through the recall procedures set forth in Section 3 below. If the  
7 charges are not sustained, the same shall be dismissed. In order to be sustained,  
8 the charges must be supported by a preponderance of reliable evidence and a two-  
9 thirds (2/3) majority weighted vote of the Board of Directors in order to find the  
10 charged party guilty. The Board of Directors may bifurcate its decision on the merits  
11 from its decision regarding an appropriate remedy. All written records of the charge,  
12 investigation, findings, notice of hearing and record of the proceeding, excluding the  
13 final decision of the Board of Directors, shall be sealed, and the entire record shall  
14 remain the sole and exclusive property of the PORAC Board of Directors.

16 Section 3. Any elected officer, Director, Trustee or Committee member may be removed from office  
17 for any act or offense constituting a serious violation of the Bylaws, Standing Rules, Rules  
18 of Order or which may otherwise be detrimental to PORAC, or a conflict of interest, upon

3 A. If the charges, or any portion thereof, are sustained, and the Board of Directors

5 office of an accused who is an elected officer, the following procedure shall be utilized.

7 (1) A recall meeting shall be noticed by the Vice President, or the Secretary if the  
8 Vice President is the person accused, within ten (10) days of the judgment of the  
9 Board of Directors and the recall meeting shall be held not less than thirty (30)  
10 days or more than sixty (60) days from the filing of that notice.

11 (2) Board of Directors shall appoint three (3) Recall Inspectors consisting of at least  
12 one member from the Region of the accused, and none being members  
13 of the Board of Directors. The Inspectors shall perform the duties necessary to  
14 conduct a fair recall and conduct such duties in a manner as set forth in  
15 Corporations Code Section 7614(b) and (c), as well as any other duties assigned  
16 by the Board of Directors.

18 B. The notice of recall meeting shall contain:

19 (1) The time and place of the meeting.

20 (2) A brief statement of the reasons the recall has been initiated.

21 (3) An advisement that if the members in attendance at the meeting vote to remove

23 (i) if the President is removed, the Vice President shall fill the vacancy pursuant  
24 to Article VIII, Section 2 of these Bylaws;

3 (ii) if the Vice President or the Treasurer is removed, the Board of Directors shall  
4 appoint a Director to fill the vacancy until a successor is elected at the next

6 C. Any individual removed from office shall be deemed ineligible to hold any elected or  
7 appointed office in PORAC for three (3) years from the date he or she was removed.

9 D. At least fifteen (15) days prior to the recall meeting, PORAC will mail to all affiliated  
10 Associations as of the date of the notice of recall, a signed statement limited to a  
11 maximum length of one (1) page (8½ by 11) by the charging party and one (1) by the

13 Directors opposed to the recall.

2 **DISCIPLINE OF ASSOCIATIONS AND MEMBERS**

3 Section 1. Any association affiliated with PORAC engaging in activities or acts inimical or  
4 inconsistent with PORAC's Articles of Incorporation, Bylaws, Standing Rules, Rules of  
5 Order or law enforcement in general, may be disciplined, including, but not limited to,  
6 having its' membership suspended or revoked. The procedures for disciplining,  
7 suspending or revoking membership shall be the same as the disciplinary procedures as  
8 provided in Article XII, Section 1. In addition to other appropriate remedial action, by a  
9 two-thirds (2/3) majority weighted vote of the Board of Directors, affiliated associations  
10 may be disciplined or have its membership suspended or revoked after the Board reviews  
11 the Investigative Committee's confidential report and affords the association's  
12 representatives to have an opportunity to speak in its defense.

14 Section 2. Failure to pay dues as prescribed by these Bylaws and Standing Rules shall result in  
15 automatic revocation of membership. The Board of Directors shall provide in the  
16 Standing Rules for grace periods, automatic reinstatement, and other procedures for  
17 failure to pay dues. (S.R.)

18  
19 Section 3. An individual member of PORAC or any member of an organization affiliated with  
20 PORAC under Article II of these Bylaws, may be disciplined for engaging in activities or  
21 acts inimical or inconsistent with PORAC's Articles of Incorporation, Bylaws, Standing  
22 Rules or law enforcement, in general, as provided in Article XII, Section 1.

2 **DISCIPLINE OF ASSOCIATIONS AND MEMBERS**

3 A. The individual member, the president of the individual member's association, and the  
4 president of the member association's Chapter shall each be notified at least thirty  
5 (30) days prior to the disciplinary hearing based on the Investigative Committee's  
6 report. The charge and Investigative Committee's report must be served with the  
7 notice of hearing. Pending the hearing, the Board of Directors may take any  
8 appropriate temporary action to protect and defend PORAC from irreparable harm.

10 B. If the charges, or any portion thereof, are sustained, the Board of Directors shall  
11 render judgment and impose any appropriate disciplinary action, excluding removal of  
12 the accused from their local association office. The discipline may include, but is not  
13 limited to, barring the individual from eligibility to hold office with PORAC, for up to  
14 three (3) years. If the charges are not sustained, the same shall be dismissed. In  
15 order to be sustained, the charges must be supported by a preponderance of reliable  
16 evidence and two thirds (2/3) majority weighted vote of the Board of Directors.

18 C. Nothing in this section shall prohibit a disciplined individual from participating in

3 Section 1. The PORAC Board of Directors may hire appropriate staff to execute and carry out the  
4 policies, programs and directives of the Association.

6 Section 2. In accordance with the standards fixed by the Board of Directors, the Chief Operating

10 including employment and termination of employment, as well as the general  
11 administration over the staff members employed by PORAC within the parameters  
12 established by the Board of Directors.

13 B. Written personnel policies, and any amendments thereto, shall be approved by the  
14 President and Vice President subject to the ratification of the Executive Committee.

16 Section 3. Notwithstanding the above, the Chief Operating Officer shall be subordinate to the

2 **INVESTIGATIVE POWERS**

3 Section 1. *In conducting any hearing scheduled pursuant to Article XII, Section 1(C) of the Bylaws,*  
4 *the Board of Directors may open the proceedings to members of PORAC in good*  
5 *standing. The Board of Directors may call for the hearing to be held in Executive*  
6 *Session, with the attendant obligations upon the Directors and members in attendance.*  
7 *The Board of Directors shall not be bound to follow strict rules of evidence at any stage*  
8 *of the proceeding. Rather, the Chair may make any appropriate ruling and the Board of*  
9 *Directors may take any appropriate action to:*

- 10 (a) *obtain relevant evidence*
- 11 (b) *exclude irrelevant evidence*
- 12 (c) *provide for reasonable due process, and*
- 13 (d) *protect the interests of PORAC and its members.*

15 Section 2. *The final decision of the Board of Directors regarding any disciplinary matter under*  
16 *Article XII, Section 1 (E) of the Bylaws, shall include a statement of the case, a summary*  
17 *of the evidence and the positions of the parties, specific findings of facts and conclusions,*  
18 *as well as the reasons or basis therefore, upon all material issues raised at the hearing.*  
19 *If the accused is found guilty of some or all of the preferred charges, the decision of the*  
20 *Board of Directors shall also include the remedy deemed appropriate and ordered by the*  
21 *Board, plus the final disposition of the case, if any. Such decisions of the Board of*  
22 *Directors may be made available for review at PORAC Headquarters (or other*  
23 *appropriate locations) by members of PORAC in good standing who agree to be bound*  
24 *to maintain the appropriate confidentiality of the decision.*

1 **S.R. Article XIII**

2 **DISCIPLINE OF ASSOCIATIONS AND MEMBERS**

3 Section 1. *Dues-Failure to Pay. Any member association of PORAC which fails to pay all of their*  
4 *dues within fifteen (15) days after their due date, shall be placed on the delinquency list*  
5 *at PORAC Headquarters. Should the dues not be received within thirty (30) days of said*  
6 *notice, their Chapter Director and local association will be notified by PORAC*  
7 *Headquarters. If at the end of three (3) months an association is still in arrears, it shall be*  
8 *suspended from and forfeit all privileges of membership in PORAC, except that the*  
9 *Executive Committee by a two-thirds (2/3) vote or the Board of Directors by a majority*  
10 *vote, may for good cause extend the three (3) month grace time and/or all membership*  
11 *privileges for a period they deem appropriate. Associations which seek an extended*  
12 *grace period must sign a written agreement to repay all PORAC dues for the grace*  
13 *period before any grace extension goes into effect. The Board of Directors shall review*  
14 *all extended grace periods in effect at the time of any Board of Directors meeting.*

15  
16 Section 2. *Dues-Reinstatement after Suspension. A suspended member and/or member*  
17 *association may be reinstated upon payment of all arrearage under such terms and*  
18 *conditions as may be determined by the Board of Directors.*

19  
20 Section 3. *Acts and offenses considered inimical and inconsistent with law enforcement under*  
21 *Article XIII of the PORAC Bylaws include, but are not limited to, efforts by associations*  
22 *affiliated with PORAC to defund any public safety organization.*

1 **S.R. Article XIV**

2 **ADMINISTRATION**

3 Section 1. *Reserve Fund. PORAC shall strive to maintain funds equal to at least three (3) months*  
4 *General Fund dues in the reserve fund to be used when necessary in compliance with*  
5 *these Bylaws.*

6 *A. In the event of a cash flow emergency, the Board of Directors or Executive Committee*  
7 *can approve the expenditure of funds not greater than one (1) month's General Fund*  
8 *dues, from the reserve funds. In the event of a natural disaster, the Board of Directors*  
9 *or Executive Committee may approve a donation from the Reserve Fund to a Relief*  
10 *Fund.*

11 *B. Only the Board of Directors can approve any additional expenditure during a fiscal*  
12 *year.*

13 *C. An Emergency (for purposes of Subsection A., above) shall be determined by the*  
14 *Board of Directors or Executive Committee upon the recommendation of the PORAC*  
15 *Treasurer or PORAC President in the Treasurer's absence. Every effort shall be*  
16 *made to replace the amount expended from the reserves as soon as financially*  
17 *possible.*

18 *D. Any unencumbered reserves at the end of the fiscal year may be placed into the*  
19 *PORAC General Fund upon the approval of the Board of Directors or Executive*  
20 *Committee.*

21 *E. Any loan against the reserve funds shall be viewed as an expenditure.*

2 **BYLAW AND STANDING RULE AMENDMENTS**

3 *Section 1. Proposed amendments to the PORAC Bylaws must be approved, in writing, by the*  
4 *submitter's association and/or the respective Chapter prior to being submitted using the*  
5 *approved online form.*

6 *Section 2. Amendments to the PORAC Bylaws shall be approved only by the members at the*  
7 *Conference of Members pursuant to Article XVI of the Bylaws.*

8 *Section 3. The Board of Directors may amend these Standing Rules provided such amendments*  
9 *are not inconsistent with the Bylaws.*

10 *Section 4. The Board of Directors may approve amendments to the Standing Rules by a majority of*  
11 *the voting Directors provided thirty (30) days written general notice of the proposed*  
12 *amendments is given to the Directors or by a two-thirds (2/3) vote if less than thirty (30)*  
13 *days written notice is provided.*
